As many of you know by now, Governor Wolf has **ordered** all non-life-sustaining businesses

across the Commonwealth to close to help stop the spread of COVID-19. Enforcement of this order will begin at 12:01 am on Saturday, March 21. You can find a list of what is and isn't considered "life-sustaining" [here](#).

For Individuals:

- If you have been laid off or have had a reduction in hours because of COVID-19, you may be eligible for unemployment. The fastest way to apply is [online](#).
- The Pennsylvania Utilities Commission has ordered a stop to all utility shut offs for public utilities under their control for the duration of Governor Wolf's emergency declaration.
- The Pennsylvania Supreme Court has prohibited evictions throughout the state through April 3.
- The federal government has postponed the FEDERAL tax filing deadline from April 15 to July 15.
- The Allegheny County Health Department and United Way have a dedicated 24/7 hotline for assistance at 1-888-856-2774.

For Business Owners:

- If you have questions as to whether your business is considered life-sustaining, please contact the Department of Community and Economic Development (DCED) at [RA-dcedcs@pa.gov](mailto:RA-dcedcs@pa.gov) or 1-877-PA-HEALTH and selection option 1. To apply for an exemption to the life-sustaining determination, please email [RA-dcexemption@pa.gov](mailto:RA-dcexemption@pa.gov).
- The Pennsylvania Industrial Development Authority (PIDA) anticipates that they will be able to start accepting applications for the Small Business First (SBF) program next week following a \$61 million transfer into the program this week. These working capital loans of up to \$100,000 will be made available to small businesses (100 employees or less) impacted by the effects of COVID-19. Additional information about PIDA can be found at their [website](#).
- The federal Small Business Administration has announced that PA small businesses and non-profits can apply for low-interest Economic Injury Disaster Loans. Info and loan applications are at [sba.gov/disaster](https://sba.gov/disaster).

Also, please keep an eye out for your official 2020 Census mailers! Making sure that every one of us counts is even more important than ever—federal funding is based on an accurate count that includes everyone, including children!
